1. **No Felony Convictions:** The Buyer is not a convicted felon and has never been convicted of any crime punishable by imprisonment for a term exceeding one year, which prohibits the Buyer from shipping, transporting, possessing, or receiving firearms under federal law (18 U.S.C. § 922(g)(1)) or applicable state law.
2. **No Domestic Violence Restraining Orders:** The Buyer is not currently subject to a court order that restrains the Buyer from harassing, stalking, or threatening an intimate partner or child of such intimate partner, or engaging in other conduct that would place an intimate partner in reasonable fear of bodily

injury, as described in 18 U.S.C. § 922(g)(8).

3. **No Domestic Violence Misdemeanors:** The Buyer has never been convicted in any court of a misdemeanor crime of domestic violence, as defined in 18 U.S.C. § 921(a)(33), which disqualifies the Buyer from possessing or receiving any firearm under 18 U.S.C. § 922(g)(9).

4. **General Eligibility:** The Buyer is of legal age to purchase and possess the firearm described herein under federal, state, and local laws, and is not otherwise prohibited by any federal, state, or local statute, regulation, or ordinance from receiving, possessing, or owning the firearm.
