### **II. GENERAL SCHEDULE OVERVIEW**

This Parenting Schedule establishes a detailed 5-2-2-5 rotating custody arrangement for the child(ren) listed above. This schedule operates on a two-week cycle, ensuring that each Parent has consistent time with the child(ren). The rotation is structured as follows: Parent A has the child(ren) for five (5) consecutive overnights, followed by Parent B having the child(ren) for two (2) consecutive overnights. This is then followed by Parent A having the child(ren) for two (2) consecutive overnights, and finally Parent B having the child(ren) for five (5) consecutive overnights. This two-week cycle then repeats.

### **III. WEEKLY ROTATION SCHEDULE**

The 5-2-2-5 parenting schedule shall be implemented as follows, commencing on the first Monday following the execution of this document, or as otherwise agreed by the Parents in writing:

**Week 1:**

\* **Parent A's Time (5 overnights):** Commences on Monday after school/daycare or at \_\_\_\_\_ (Time) if no school/daycare, and continues through Friday morning, when the child(ren) are returned to school/daycare or exchanged to Parent B at \_\_\_\_\_ (Time).

\* **Parent B's Time (2 overnights):** Commences on Friday after school/daycare or at \_\_\_\_\_ (Time) if no school/daycare, and continues through Sunday evening, when the child(ren) are returned to Parent A at \_\_\_\_\_ (Time).

**Week 2:**

\* **Parent A's Time (2 overnights):** Commences on Monday after school/daycare or at \_\_\_\_\_ (Time) if no school/daycare, and continues through Wednesday morning, when the child(ren) are returned to school/daycare or exchanged to Parent B at \_\_\_\_\_ (Time).

\* **Parent B's Time (5 overnights):** Commences on Wednesday after school/daycare or at \_\_\_\_\_ (Time) if no school/daycare, and continues through Sunday evening, when the child(ren) are returned to Parent A at \_\_\_\_\_ (Time).

The cycle then repeats with Week 1.

**IV. EXCHANGE LOGISTICS**

A. **Exchange Location:** All exchanges of the child(ren) shall occur at: (e.g., child's school/daycare, a neutral public location, or the residence of the receiving parent).

**B. Exchange Time:**

\* On school days, exchanges shall occur at the time of school/daycare pick-up or drop-off.

\* On non-school days or during school breaks, exchanges shall occur at

C. **Transportation:** The Parent whose scheduled time is commencing shall be responsible for picking up the child(ren) from the other Parent or designated exchange location.

D. **Timeliness:** Both Parents shall be punctual for all exchanges. If a Parent anticipates being more than fifteen (15) minutes late for an exchange, they shall notify the other Parent immediately.

#### **V. HOLIDAYS AND SPECIAL OCCASIONS**

This 5-2-2-5 Parenting Schedule shall be superseded by a separate Holiday and Special Occasion Schedule, which shall govern the child(ren)'s time with each Parent during designated holidays, school breaks, and special events. In the absence of a separate Holiday and Special Occasion Schedule, the Parents shall mutually agree upon arrangements for such periods in advance.

#### **VI. VACATIONS**

Each Parent shall be entitled to \_\_\_\_\_ (Number) non-consecutive weeks of vacation with the child(ren) annually. Any modification to this Parenting Schedule must be made in writing and signed by both Parents, or by further order of a court of competent jurisdiction.
