V. TRANSFER OF OWNERSHIP

Upon execution of this Bill of Sale and receipt of the full purchase price, the Seller transfers all rights, title, and interest in the Vehicle to the Buyer. The Buyer assumes all responsibility for the Vehicle from the date of sale.

VI. GOVERNING LAW

This Bill of Sale shall be governed by and construed in accordance with the laws of the Commonwealth of Kentucky.

VII. ENTIRE AGREEMENT

This Bill of Sale constitutes the entire agreement between the Seller and the Buyer regarding the sale of the Vehicle and supersedes all prior discussions, negotiations, and agreements, whether oral or written.
