1. DEFINITIONS

a. "Principal" refers to _____ , the party for whom the services are rendered or sales are made.

b. "Agent/Salesperson" refers to _____ , the party who will earn commission for services rendered or sales made.

c. "Commission" refers to the payment earned by the Agent/Salesperson based on the terms outlined in this Agreement.

d. "Net Sales Price" refers to the total sales price of goods or services sold, excluding taxes, shipping, and handling.

2. COMMISSION RATE AND PAYMENT

a. The Principal agrees to pay the Agent/Salesperson a commission of _____ % on all sales made by the Agent/Salesperson.

b. Commissions will be calculated based on the Net Sales Price.

c. Payment of commissions will be made on a monthly basis, no later than the _____ day of the following month.

d. All commission payments will be made via _____ (e.g., bank transfer, check), and the Agent/Salesperson shall provide necessary details for such payments.

3. CONDITIONS FOR COMMISSION

4. TERM AND TERMINATION

c. Upon termination, the Agent/Salesperson shall be entitled to commissions on sales completed prior to the termination date, subject to the conditions outlined in this Agreement.

5. GOVERNING LAW AND JURISDICTION

This Agreement shall be governed by and construed in accordance with the laws of the State of _____ . Any disputes arising under or in connection with this Agreement shall be resolved in the courts located in _____ .

6. SEVERABILITY

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

8. AMENDMENTS

Any amendments or modifications to this Agreement must be in writing and signed by both parties.
