JUDGMENT AND DECREE OF DISSOLUTION OF MARRIAGE

9. **Health Insurance:** No orders regarding health insurance for the children or parties are necessary or appropriate.
10. **Tax Exemptions/Credits:** This Decree does not specify the allocation of tax exemptions or credits.
11. **Restraining/Protective Orders:** No restraining or protective orders are included in this Decree.
12. **Name Change:** No order for a name change is included in this Decree.
13. **Attorney's Fees and Costs:** No orders regarding attorney's fees or costs are included in this Decree.
14. **Other Orders:** There are no other orders or provisions to be included in this Decree.

III. ORDERS AND DECREE

Based upon the foregoing Findings of Fact, it is hereby **ORDERED, ADJUDGED, AND DECREED** as follows:

1. **Dissolution of Marriage:** The marriage between Petitioner, [Petitioner's full legal name], and Respondent, [Respondent's full legal name], is hereby dissolved, and the parties are restored to the status of single persons.
2. **Children:** There are no minor children of the marriage, and therefore no orders regarding child custody, visitation, or child support are made.
