NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties agree as follows:

1. Scope of Work

The Electrical Contractor agrees to perform the following services:

2. Payment Terms

a. The Client agrees to pay the Electrical Contractor the total sum of \$

b. Payment shall be made as follows:

c. Any additional work or materials not included in the original scope of work shall be billed separately and will require prior written approval from the Client.

5. Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect. The parties agree to replace any invalid provision with a valid provision that most closely approximates the intent and economic effect of the invalid provision.

6. Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements or understandings, whether written or oral, relating to the subject matter herein. No representations, warranties, or inducements have been made to either party except as expressly set forth herein.

7. Notices

Any notice required or permitted under this Agreement shall be in writing and shall be deemed given when delivered personally, sent by certified mail, return receipt requested, or sent by email to the addresses specified above. Notices sent by certified mail shall be deemed received three (3) business days after mailing.

8. Amendment

This Agreement may only be amended or modified by a written agreement signed by both parties. Any waiver of any term or condition of this Agreement must be in writing and signed by the party against whom such waiver is sought to be enforced.

9. Default and Remedies

In the event of a default by either party, the non-defaulting party shall have the right to pursue any and all remedies available at law or in equity, including but not limited to specific

performance, damages, and termination of this Agreement.

10. Termination

Either party may terminate this Agreement upon written notice if the other party breaches any material term of this Agreement and fails to cure such breach within

_____ days of receiving notice of the breach. Upon termination, the Client shall pay for all Services rendered and materials provided up to the date of termination.

11. Insurance

The Electrical Contractor shall maintain adequate insurance coverage, including general liability and workers' compensation insurance, and shall provide proof of such insurance upon request by the Client.

12. Indemnification

The Electrical Contractor agrees to indemnify, defend, and hold harmless the Client from and against any and all claims, liabilities, damages, and expenses arising out of or in connection with the performance of the Services, except to the extent caused by the negligence or willful misconduct of the Client.
