V. SELLER'S CERTIFICATIONS

1. The Seller is the lawful owner of the Firearm.

2. The Seller has full authority to sell and transfer the Firearm.
3. The Firearm is free and clear of all liens, encumbrances, and claims.
4. To the best of the Seller's knowledge, the Firearm has not been used in the commission of a crime.
5. To the best of the Seller's knowledge, the Firearm is not stolen.

VI. BUYER'S CERTIFICATIONS AND DISCLOSURES

The Buyer certifies, represents, and warrants that they are legally permitted to purchase and own firearms under federal and state law. Specifically, the Buyer certifies that:
