7. TERMINATION

Either party may terminate this Agreement with written notice of 30 days if the other party breaches any material term of this Agreement and fails to cure such breach within 15 days of receiving notice of the breach. Upon termination, the Freelancer shall be compensated for all

Services performed up to the termination date.

8. DEFAULT AND REMEDIES

In the event of default by either party, the non-defaulting party shall have the right to seek all remedies available at law or in equity, including specific performance and injunctive relief.

9. AMENDMENTS

This Agreement may only be amended in writing signed by both parties. Any waiver of any provision of this Agreement shall not be deemed a waiver of any other provision.

10. NOTICES

Any notice required or permitted under this Agreement shall be in writing and shall be deemed given when delivered personally, sent by email, or mailed by certified mail, return receipt requested, to the addresses listed above. Notices sent by email shall be deemed received on the next business day.
