III. ODOMETER DISCLOSURE

IV. REPRESENTATIONS AND WARRANTIES

1. Title. The Seller represents and warrants that they are the true and lawful owner of the Vehicle and have full right and authority to sell and transfer the same. The Seller warrants that the Vehicle is free and clear of all liens, encumbrances, and claims of others, except as follows:

2. "AS-IS" Condition. EXCEPT FOR THE WARRANTY OF TITLE SET FORTH ABOVE, THE VEHICLE IS SOLD "AS-IS, WHERE-IS," AND THE SELLER MAKES NO REPRESENTATIONS OR WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, REGARDING THE VEHICLE, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR CONDITION.

3. Inspection. The Buyer acknowledges that they have been given the opportunity to inspect the Vehicle or have it inspected by a third party of their choosing. The Buyer accepts the Vehicle in its current condition, including any known or unknown defects.

V. TRANSFER OF TITLE AND REGISTRATION

1. Title Transfer. The Seller agrees to sign the Certificate of Title and deliver it to the Buyer at the time of payment, or within _____ days of the Effective Date.

2. License Plates. Pursuant to Illinois law, the Seller shall remove the license plates from the Vehicle upon transfer of ownership. The Buyer is responsible for obtaining new license plates and registration from the Illinois Secretary of State.

This Agreement shall be governed by and construed in accordance with the laws of the State of Illinois.
