Pursuant to Louisiana Civil Code Article 2520 et seq., the Buyer hereby waives any and all rights to redhibition or reduction of the purchase price for any vices or defects, latent or apparent, in the Vehicle. The Buyer acknowledges that they have had the opportunity to inspect the Vehicle or have had the Vehicle inspected by a professional of their choosing, and the Buyer accepts the Vehicle in its current state at the time of sale.

The Seller warrants and covenants that the Seller is the lawful owner of the Vehicle, has the full legal right and authority to sell and transfer the same, and that the Vehicle is free and clear of all liens, security interests, loans, encumbrances, or adverse claims of any nature.

V. TRANSFER OF TITLE AND RISK OF LOSS

The Seller agrees to deliver the certificate of title and all other necessary registration documents for the Vehicle to the Buyer immediately upon receipt of the Purchase Price.

The risk of loss, damage, or destruction of the Vehicle, as well as all liabilities arising from the operation and ownership of the Vehicle, shall pass from the Seller to the Buyer immediately upon the execution of this Bill of Sale and delivery of the Vehicle to the Buyer. The Buyer shall be solely responsible for obtaining insurance, registration, and licensing for the Vehicle in accordance with Louisiana law.

VI. GOVERNING LAW

This Bill of Sale and the transfer of ownership hereunder shall be governed by, construed, and enforced in accordance with the laws of the State of Louisiana.
