### V. SCOPE OF AUTHORITY

**The Parent(s) hereby delegate to the Temporary Guardian(s) the temporary authority to make decisions regarding the care, custody, and welfare of the minor child(ren) identified in Section II, including but not limited to the following powers:** 1. **Medical Care:** To consent to any necessary medical, dental, surgical, hospital, or other health care treatment, including emergency treatment, for the minor child(ren). This includes the authority to authorize the administration of medication, diagnostic procedures, and surgical operations deemed necessary by a licensed physician, dentist, or other healthcare provider. The Temporary Guardian(s) shall make reasonable efforts to notify the Parent(s) of any

significant medical decisions.

2. **Educational Decisions:** To enroll the minor child(ren) in school or childcare, communicate with school officials, access educational records, and make decisions regarding the minor child(ren)'s education and extracurricular activities.
3. **General Welfare:** To provide for the daily care, supervision, and discipline of the minor child(ren), including decisions regarding food, shelter, clothing, and recreational activities.
4. **Travel:** To authorize the minor child(ren) to travel within the United States with the Temporary Guardian(s).
5. **Emergency Situations:** To act in any emergency situation concerning the minor child(ren) as a prudent parent would, exercising all necessary judgment and discretion.

The Parent(s) acknowledge that they remain legally responsible for the support and maintenance of the minor child(ren) and for any liabilities incurred by the minor child(ren) during the term of this Delegation.

## **VI. LIMITATIONS ON AUTHORITY**

- The Temporary Guardian(s) shall not have the authority to:**
1. Consent to the marriage or adoption of the minor child(ren).
  2. Authorize any invasive medical procedures or non-emergency surgeries without prior consultation and consent from the Parent(s), unless such delay would endanger the child's life or health.
  3. Make any decisions that would permanently alter the legal rights or status of the minor child(ren).

## **VII. REVOCATION**

This Delegation is fully revocable by the Parent(s) at any time, with or without cause, by providing written or verbal notice to the Temporary Guardian(s). Upon revocation, all authority granted herein shall immediately terminate.
