The Lessee shall keep the Premises in a clean and orderly condition. The Lessee shall be responsible for any damage caused to the Premises by the Lessee or the Lessee's guests. The Lessor shall be responsible for structural repairs to the Premises, provided such repairs are not necessitated by the actions or negligence of the Lessee.

7. INSURANCE

The Lessee shall maintain liability insurance for any vehicles parked on the Premises and shall provide proof of such insurance to the Lessor upon request.

8. TERMINATION

Either party may terminate this Agreement by providing thirty (30) days written notice to the other party. Upon termination, the Lessee shall vacate the Premises and remove all personal property.

9. DEFAULT

In the event of a default by the Lessee, including but not limited to failure to pay rent or breach of any term of this Agreement, the Lessor may terminate this Agreement and pursue any remedies available under law, including eviction and recovery of damages.

10. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the State of

11. SEVERABILITY

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

12. ENTIRE AGREEMENT

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations, representations, or agreements, whether written or oral.

13. AMENDMENTS

This Agreement may only be amended by a written document signed by both parties.

14. NOTICES

Any notice required or permitted under this Agreement shall be in writing and shall be deemed delivered when delivered in person or deposited in the United States mail, postage prepaid, addressed to the parties at their respective addresses set forth above.

15. WAIVER

The failure of either party to enforce any provision of this Agreement shall not be deemed a waiver of that provision or any other provision of this Agreement.
