VI. USE OF PREMISES

- 1. **Permitted Use:** The Parking Space shall be used solely for the parking of the vehicle(s) listed in Section V. The vehicle must be operational, fully insured, and currently registered with the appropriate government authority.
- 2. **Prohibited Acts:** The Tenant shall not:
- a. Perform vehicle maintenance, repairs, or oil changes on the Premises (except for emergency flat tire changes or battery jumps).
 - b. Store personal items, trash, tires, or hazardous materials in the Parking Space.
 - c. Live or sleep in the vehicle while parked on the Premises.
 - d. Park any trailers, boats, or recreational vehicles without prior written consent.
 - e. Block access to other parking spaces or driveways.

VII. LIABILITY AND INDEMNIFICATION

- 1. **Risk of Loss:** The Tenant acknowledges that use of the Parking Space is at the Tenant's sole risk. The Landlord shall not be responsible for any damage to the Tenant's vehicle, theft of the vehicle, or theft of contents from within the vehicle, regardless of the cause, including but not limited to fire, flood, collision, or criminal acts of third parties.
- 2. **Indemnification:** The Tenant agrees to indemnify, defend, and hold harmless the Landlord from any and all claims, demands, liabilities, losses, costs, and expenses (including reasonable attorneys' fees) arising from the Tenant's use of the Parking Space or any breach of this

Agreement.

3. **Insurance:** The Tenant is solely responsible for maintaining adequate automobile insurance coverage for the vehicle(s) parked on the Premises.

VIII. ASSIGNMENT AND SUBLETTING

The Tenant shall not assign this Agreement or sublet the Parking Space to any other party without the prior written consent of the Landlord. Any unauthorized assignment or sublease shall be void and constitute a material breach of this Agreement.

IX. DEFAULT AND REMEDIES

If the Tenant fails to pay rent when due or violates a	any other term of this Agreement, the
Landlord may provide a written notice of default. If	the default is not cured within
days of	receipt of notice, the Landlord may:

- 1. Terminate this Agreement immediately;
- 2. Tow the Tenant's vehicle at the Tenant's sole expense; and
- 3. Pursue any other remedies available at law or in equity.

X. TOWING AUTHORIZATION

The Tenant acknowledges that any vehicle parked in the Parking Space in violation of this Agreement, or any vehicle not listed in Section V, may be towed at the vehicle owner's expense without further notice, subject to applicable state and local laws.

XII. ENTIRE AGREEMENT
