II. DESCRIPTION OF PERSONAL PROPERTY

For valuable consideration, the Seller hereby sells, transfers, and conveys to the Buyer all of the Seller's rights, title, and interest in and to the following personal property:

1. **Ownership and Title:** The Seller warrants and covenants that the Seller is the lawful owner of the personal property, has full legal authority to sell and transfer the same, and that the property is free and clear of all liens, security interests, encumbrances, claims, and demands of any kind. The Seller agrees to defend the title to the property against the lawful claims of all persons.

2. **"As-Is" Disclaimer:** Except for the warranty of title set forth above, the personal property is sold in its current condition, "AS-IS, WHERE-IS," with all faults, defects, and imperfections. The Seller makes no express or implied warranties, representations, or guarantees of any kind regarding the condition, quality, merchantability, fitness for a particular purpose, or operation of the personal property. The Buyer acknowledges that they have had the opportunity to inspect the property (or have it inspected by a

professional of their choosing) and accepts the property in its current state.

V. DELIVERY AND TRANSFER OF OWNERSHIP

Upon receipt of the full purchase price, the Seller shall deliver physical possession of the personal property to the Buyer, along with any certificates of title, registration documents, keys, or other documentation necessary to transfer lawful ownership of the property in the State of Rhode Island. The Buyer shall assume all responsibility, liability, and costs associated with the transport, registration, titling, licensing, and insurance of the property from the moment of delivery.

VI. GOVERNING LAW

This Bill of Sale shall be governed by, interpreted, and enforced in accordance with the laws of the State of Rhode Island, without regard to its conflict of law principles. Any legal action arising out of this transaction shall be brought in the appropriate state court located in Rhode Island.
